



## EITC Finder's Credit Incentive Program

Parents can now earn a Finder's Incentive for bringing in EITC (PA Educational Improvement Tax Credit) dollars to the FCS Scholarship Program – up to 10% of dollars received by our school will be deducted from your tuition bill!!

The Pennsylvania Educational Improvement Tax Credit (EITC) program provides tax credits to eligible individuals or businesses with a PA tax bill of at least \$3,150 (90% of the minimum contribution of \$3,500) that contribute to an approved scholarship organization. ### How it Works:

Current parent introduces the EITC program to the eligible individual or business owner, who then decides to participate. Parents are encouraged to refer the individual/business owner to Angela Fox or Sheila Boyer for detailed instructions. After the individual/business applies for the credit, makes the pledged contribution to the scholarship program, and FCS actually receives the funds, a tuition credit equal to 10%\* of the funds received will be granted to the referring family.

### Guidelines for Program:

- Although current parties paying tuition to FCS (i.e. – parents, grandparents, etc.) are allowed to donate through this EITC program, they are not eligible to receive the tuition credit on EITC funds that they donate personally.
- \* If you currently pay a reduced tuition rate, the finder's credit will be reduced by the same percentage as the tuition discount you receive.\*
- This form must be received by FCS prior to the funds arrival at the school.

(If the referring family does not desire the tuition credit but is willing to use this credit to help with the tuition of a fellow FCS family, please contact Sheila Boyer.)

Since EITC continues to play an important role in the ongoing financial stability of Faith Christian, we urge parents to support this program.
